**THE CONTROLLED WASTE (REGISTRATION OF CARRIERS AND SEIZURE OF VEHICLES)  
REGULATIONS (NORTHERN IRELAND) 1999 (as amended)**

I refer to your application to renew your upper tier waste Carrier licence, which has now been approved by the Northern Ireland Environment Agency.

I enclose your registration Certificate and copy of entry. Please advise me immediately if you find that any of these document details are incorrect or need amendment. You must notify NIEA within 28 days regarding any change to your name, contact details or principal place of business address. This is in case the agency needs to contact you and to update the public register. NIEA may remove you from the register if your details are no longer valid. Should the registered legal person change, you are required to make a new application and pay the relevant fee. For example if you are registered as an individual, but then form a company, you will need to apply again.

**Please note that under Article 42 (3) any person engaged in transporting waste may be asked to produce evidence of registration by an authorised officer of the Department or a Police officer. Therefore, I would advise that all of your company vehicles involved in the transport of waste should carry evidence of authority to do so, in the form of a Certificate. I wish to advise you that during the period of this registration if the department is not satisfied that a person is fit to hold or continue to hold a registration, it may decide to revoke the registration or refuse to issue any further authorisations. Such action will be taken in accordance with the Departments policy on Relevant Convictions.**

The Certificate of Registration is a valuable document. Please ensure that its use is carefully controlled to avoid loss or damage.

Please note that your registration will expire on 04/02/2017 and you will be contacted 6 months prior to expiry to renew your registration.
